Injections lead to peak serum concentrations in 30-60 minutes. Topical gentamicin is readily absorbed from large burned, denuded, or granulating areas but not through intact skin.

Absorption of gentamicin is faster and greater with the cream compared to the ointment.

Gentamicin is absorbed in small quantities following topical application to the eye. Gentamicin is

also absorbed in small amounts following topical application to the ear (especially if the eardrum is perforated or if tissue damage is present). Gentamicin is very poorly absorbed orally.
