#### **SECTION4 FIRST-AID MEASURES**

### Skin Exposure:

# Most important symptoms and effects, both acute and delayed:

Prolonged or repeated exposure can cause: Vomiting, Diarrhoea, Abdominal pain, Rats exposed to 1-methyl-2-pyrrolidone at a concentration of 1 mg/L as an aerosol for 10days showed depletion of hematopoietic cells in the bone marrow and atrophy of the lymphoid tissues of the thymus, spleen, and lymph nodes.
