12.3 Bioaccumulative potential

An estimated BCF of 2.3 was calculated for 2,4-hexadienal(SRC), using a estimated log Kow of 1.4(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC), provided the compound is not altered physically or chemically once released into the environment.

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 2,4-hexadienal can be estimated to be 17(SRC). According to a classification scheme(2), this estimated Koc value suggests that 2,4-hexadienal is expected to have very high mobility in soil.

- 13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
