

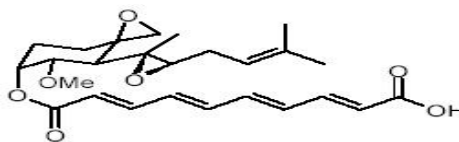

It was isolated in 1949 from the microbial organism *Aspergillus fumigatus*. Metabolized by the liver to the reactive intermediate Alternariol. Exposure may produce acute necrosis, cirrhosis and carcinoma of the liver. Induces DNA damage.
