

5.Discussion of traceability

This calibrant is certified on the basis of gravimetric preparation [4]. Thus the certified value(mass concentration of U-[¹³C₁₄]-Alternariol, U-[¹³C₁₅]-Alternariol monomethyl ether in Methanol) is based on the weighed amount of the starting material and is therefore traceable to the stated purity of the solid raw material. High purity material represents a practical realization of concentration units, through conversion of mass to molar quantity.

The certified concentration of the gravimetric prepared solution was confirmed by HPLC-FLD against an independently prepared reference batch of unlabeled Alternariol, Alternariol monomethyl ether.
