#### Precautions for safe handling

<b>Technical measures:</b>	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Wash hands and face thoroughly after handling. Use a ventilation, local exhaust if vapour or aerosol will be generated.
<b>Advice on safe handling:</b>	Avoid contact with skin, eyes and clothing. A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.

<b>Storage conditions:</b>	Keep container tightly closed. Store in a cool and dark place. Store away from incompatible materials such as oxidizing agents.
