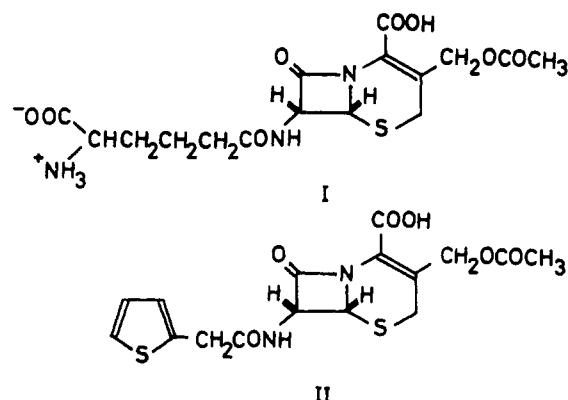


The Total Synthesis of Cephalosporin C¹

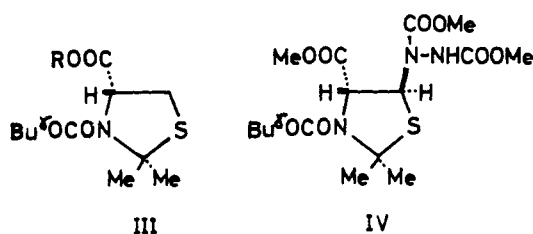

Cephalosporin C (I), a product of the metabolism of

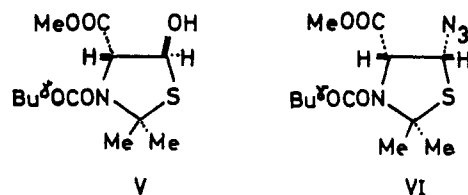


Cephalosporium acremonium, was isolated by Newton and Abraham in 1955,² and its structure was established in 1961 through chemical³ and X-ray crystallographic⁴ studies. The unusual antimicrobial properties of cephalosporin C and especially of substances prepared from the natural product by chemical modification, of which cephalothin (II)⁵ may serve as an example, have attracted widespread interest. We now wish to record the first total syntheses of cephalothin and cephalosporin C.

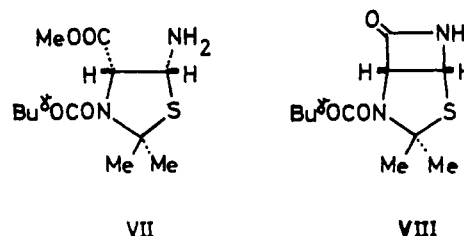
L-(+)-Cysteine was converted into L-(-)-2,2-dimethylthiazolidine-4-carboxylic acid,⁶ which with pyridine and *t*-butoxycarbonyl chloride, prepared *in situ* from *t*-butyl alcohol, phosgene, and pyridine in methylene chloride at -74° , gave L-(-)-N-*t*-butoxycarbonyl-2,2-dimethylthiazolidine-4-carboxylic acid⁷ (III,



R = H), mp $114-114.5^{\circ}$, $[\alpha]^{20D} -85^{\circ}$ (*c* 1.34, CHCl_3). The corresponding ester⁷ III (R = Me), mp $18.5-21^{\circ}$, $[\alpha]^{20D} -77^{\circ}$ (*c* 1.50, CHCl_3), prepared from the acid with diazomethane, reacted with excess dimethyl azodicarboxylate at 105° during 45 hr to give the hydrazo diester⁷ IV, mp $136-137.5^{\circ}$, $[\alpha]^{20D} +98^{\circ}$ (*c* 1.45, CHCl_3). Oxidation of IV with 2.2 moles of lead tetraacetate in boiling benzene for 2 hr, followed by treatment of the reaction mixture with excess anhydrous sodium acetate in boiling dry methanol for 24 hr, gave the *trans* hydroxy ester⁷ V, mp $101-102^{\circ}$, $[\alpha]^{20D} +48^{\circ}$

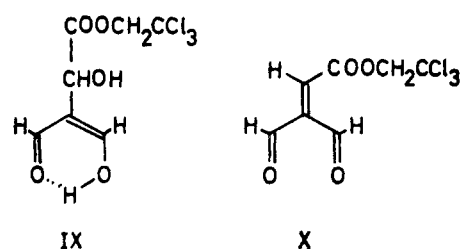


(*c* 1.14, CHCl_3).⁸ The latter was transformed by treatment in dimethylformamide with excess diisopropylethylamine and methanesulfonyl chloride, followed by concentrated aqueous sodium azide, to the *cis* azido ester⁷ VI, mp $55-56^{\circ}$, $[\alpha]^{20D} -525^{\circ}$ (*c* 1.01, CHCl_3), which was reduced in methanol by aluminum amalgam at -15° during 24 hr to the *cis* amino ester⁷ VII, mp $64-65.5^{\circ}$,



$[\alpha]^{20D} -113^{\circ}$ (*c* 0.80, CHCl_3), whose structure was confirmed by a complete X-ray crystallographic study.⁸ With triisobutylaluminum in toluene, the amino ester afforded the β -lactam⁷ VIII, mp 120.5° , $[\alpha]^{20D} -274^{\circ}$ (*c* 0.52, CHCl_3), the structure of which was also confirmed by X-ray crystallographic analysis;⁸ it is worthy of note that this remarkable substance contains the basic structural elements common to cephalosporin C, its transformation products, and the penicillins.

In a parallel series of reactions, di- β,β,β -trichloroethyl *d*-tartrate,⁷ mp $101.5-103.5^{\circ}$, $[\alpha]^{20D} +9^{\circ}$ (*c* 1.04, CHCl_3), from *d*-tartaric acid and excess β,β,β -trichloroethanol in boiling toluene in the presence of *p*-toluenesulfonic acid, was oxidized by sodium metaperiodate in aqueous methanol to β,β,β -trichloroethyl glyoxylate hydrate,⁷ mp $94.5-95.5^{\circ}$, which was condensed in aqueous solution with the sodium salt of malondialdehyde to give the aldol⁷ IX, mp $114-116^{\circ}$,



$\lambda\lambda_{\text{max}}$ 247 μ (ϵ 19,100, EtOH-H^+), 269 μ (27,600, EtOH-OH^-). When IX in 1,2-dimethoxyethane solution was added to distilling *n*-octane, dehydration occurred with formation of the highly reactive dialdehyde X, λ_{max} 234 μ (cyclohexane), which was utilized directly, without purification.

Condensation of the β -lactam VIII with the dialdehyde X in *n*-octane at 80° during 16 hr afforded the adduct⁷

(8) The structure of this ester was most convincingly demonstrated by its preparation from the action of diazomethane upon the corresponding acid,⁷ mp 187.5° , $[\alpha]^{20D} +123^{\circ}$ [*c* 1.02 (1 *N* NaOH)], obtained by an alternative method; the structure of the acid was rigorously established by a complete X-ray crystallographic study. 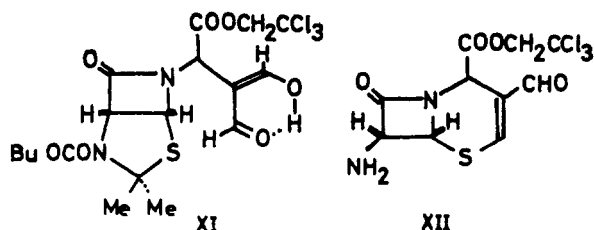

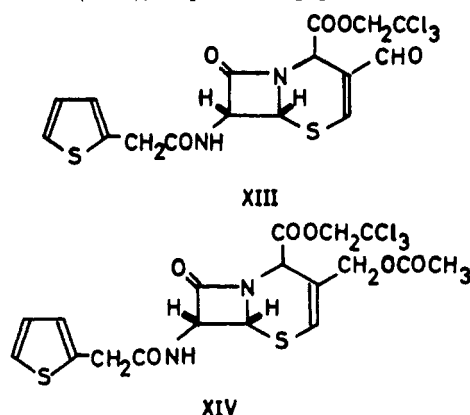

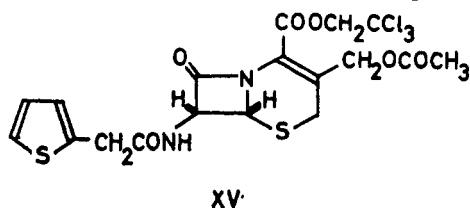


XI, $[\alpha]^{20D} -122^\circ$ (c 0.46, CHCl_3), which in trifluoroacetic acid solution at room temperature during 2.5 hr was transformed to the aminoaldehyde XII, λ_{max} 292 $m\mu$ (13,600, EtOH); this sensitive intermediate was used in subsequent reactions without extensive purification.

Condensation of the aminoaldehyde XII in benzene with thiophene-2-acetyl chloride in the presence of pyridine led to the amide⁷ XIII, mp 135–135.5°, $[\alpha]^{20D} +485^\circ$ (c 1.14, CHCl_3), which was treated in tetrahydrofuran solution with diborane, followed by pyridine-acetic anhydride, to give isocephalothin β,β,β -trichloroethyl ester⁷ (XIV), mp 102°, $[\alpha]^{20D} +320^\circ$ (c 1.01,

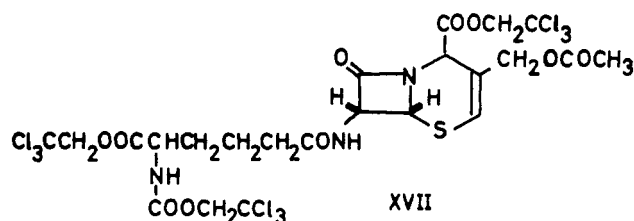
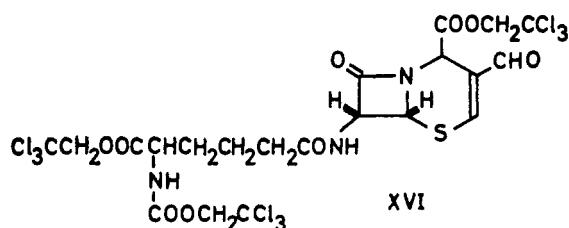


CHCl_3). When the iso ester was allowed to stand in anhydrous pyridine solution at room temperature during 3 days it was smoothly equilibrated ($K_{\text{normal/iso}} = 1/3$) with the normal ester⁷ XV, mp 120–123°,

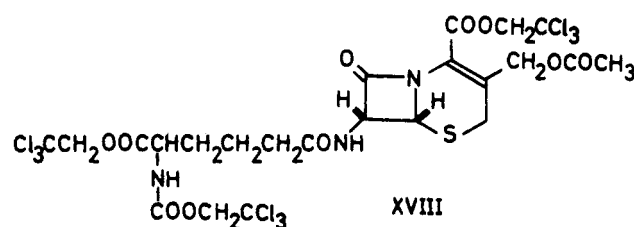


$[\alpha]^{20D} +14^\circ$ (c 0.95, CHCl_3), which was easily separated by chromatography on silica gel, and reduced by zinc dust in 90% aqueous acetic acid at room temperature to cephalothin (II), mp 160–160.5°, $[\alpha]^{20D} +50^\circ$ (c 1.03, CH_3CN), whose properties were identical in all respects with those of material prepared from natural cephalosporin C.⁵

In another series of reactions the aminoaldehyde XII was condensed in tetrahydrofuran with N - β,β,β -trichloroethyloxycarbonyl-D-(-)- α -aminoadipic acid,⁷ mp 137.5°, $[\alpha]^{20D} -8^\circ$ (c 1.03, 1 N NaOH), in the presence of dicyclohexylcarbodiimide. The crude reaction mixture was esterified, using β,β,β -trichloroethanol in methylene chloride in the presence of dicyclohexylcarbodiimide and pyridine. Elution of the resulting material from silica gel by benzene-ethyl acetate (3:1) gave two products, of which XVI was the more polar, since it was converted by reduction in



tetrahydrofuran with diborane, followed by acetylation with acetic anhydride-pyridine to the iso ester⁷ XVII, mp 111–114°, $[\alpha]^{20D} +220^\circ$ (c 1.01, CHCl_3). When the latter was allowed to stand in pyridine at room temperature for 3 days, it was equilibrated ($K_{\text{normal/iso}} = 1/4$) with the normal ester⁷ XVIII, mp 157–159°, $[\alpha]^{20D}$



$+40^\circ$ (c 0.76, CHCl_3), which was easily separated by chromatography on silica gel and reduced by zinc dust and 90% aqueous acetic acid at 0° during 2.5 hr to cephalosporin C (I), identical with natural material in paper chromatographic behavior, and in antibacterial activity against *Neisseria catarrhalis*, *Alcaligenes faecalis*, *Staphylococcus aureus*, and *Bacillus subtilis*; further, the synthetic crystalline barium salt, $[\alpha]^{20D} +80^\circ$ (c 0.57, H_2O), was identical in optical rotation and spectroscopic properties with the salt of natural cephalosporin C.

Pyracyloquinone

Sir:

Although Hückel's $4n + 2$ rule strictly applies only to monocyclic hydrocarbons, polycyclic aromatics possessing this number of π electrons are frequently misnamed Hückel aromatics. Nevertheless, the simple LCAO calculations do predict these compounds to have a high resonance energy. Brown¹ predicted that pyracylene (I), a $4n + 2$ aromatic hydrocarbon, should
