Section 3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

Hygroscopic (absorbs moisture from the air).Air sensitive.The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye:

May cause eye irritation. The toxicological properties of this material have not been fully investigated.

Skin:

May cause skin irritation. The toxicological properties of this material have not been fully investigated.

Ingestion:

May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated.

Section 4 - FIRST AID MEASURES

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin:

Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

If victim is conscious and alert, give 2-4 cupfuls of milk or water.

Section 5 - FIRE FIGHTING MEASURES

General Information:

As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Vapors may be heavier than air. They can spread along the ground and collect in low or confined areas.

Keep container closed when not in use. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from water.
