General advice

4.2 Most important symptoms/effects, acute and delayed

SYMPTOMS: Symptoms of exposure to this compound may include pronounced coloring of the skin and blockage of the upper respiratory tract.

ACUTE/CHRONIC HAZARDS: This compound may be absorbed through the skin. When heated to decomposition it emits toxic fumes of nitrogen oxides.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

/SRP:/ Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. /Poisons A and B/

PIGMENT RED 3 may form toxic gases with acids, aldehydes, amides, carbamates, cyanides, inorganic fluorides, halogenated organics, isocyanates, ketones, metals, nitrides, peroxides, phenols, epoxides, acyl halides, and strong oxidizing or reducing agents. May form flammable gases with alkali metals. Explosive combination can occur with strong oxidizing agents, metal salts, peroxides, and sulfides.

Evaluation: There is inadequate evidence in humans for the carcinogenicity of CI Pigment Red 3. There is limited evidence in experimental animals for the carcinogenicity of CI Pigment Red 3. Overall evaluation: CI Pigment Red 3 cannot be classified as to its carcinogenicity to humans (Group 3).

12.3 Bioaccumulative potential

An estimated BCF of 10 was calculated for C.I. Pigment Red 3(SRC), using an estimated log Kow of 6.5(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of C.I. Pigment Red 3 can be estimated to be 1.3×10^5 (SRC). According to a classification scheme(2), this estimated Koc value suggests that C.I. Pigment Red 3 is expected to be immobile in soil.

13. Disposal considerations

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
