In rat experiments, large doses administered over a period of six months reduced the size of the testes, prostate gland, and seminal vesicles. Cimetidine has been clearly associated with antiandrogenic effects in adult humans. These effects include the occasional development of gynecomastia and a decline in sperm count (without loss of fertility) among men treated with this drug.
