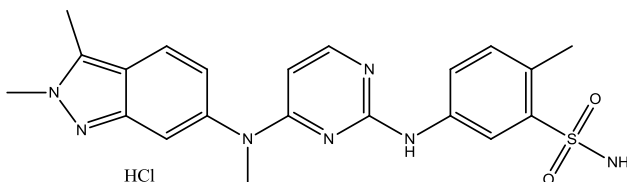

### HAZARDS IDENTIFICATION

Not considered hazardous when handled under normal conditions with good house keeping.

### FIRST-AID MEASURES

#### In case of inhalation:

Remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention.

**ACCIDENTAL RELEASE MEASURES**

Ensuring personal safety, mark out contaminated area with signs and prevent unauthorised access. Turn leaking containers up to prevent further Evacuate area. Wear self-contained breathing apparatus, rubber boots & heavy rubber gloves. Sweep-up/absorb in suitable material, place in a container and hold for disposal. Avoid raising dust. Ventilate area and wash spill site after pick-up complete.

**Handling**

Technical measures - local exhaust ventilation necessary - avoid dust formation, consider dust explosion hazard

**Storage**

Store in original container in a cool dark place, keep container tightly closed.

### Spill response

Wear approved respiratory protection,chemically compatible gloves and protective clothing.Wipe up spillage or collect spillage using a high efficiency vacuum cleaner.Avioid breathing dust.Wash spill site.Place spillage and all contaminated cleanup materials in thick plastic hazardous waste disposal bag or leakproof container and label it.
