4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media:** Dry chemical, foam, water spray, carbon dioxide.

- Precautions for firefighters:** Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

6. ACCIDENTAL RELEASE MEASURES

- Prevention of secondary hazards:** Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

Precautions for safe handling

- Technical measures:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Keep away from flames and hot surfaces. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated.
