

Destruxin A is a cyclic peptide mycotoxin from entomogenous fungus *Metarhizium anisopliae*, which has insecticidal, antiviral and anti-proliferative activities. Destruxin A was highly toxic to blood cells. In vivo, only 0.25µg/mL of Destruxin A was needed to induce hemolymph perforation and pyconstriction.


