2.2 Instruction for the correct use of the RM

The compound should be stored at $-20^{\circ}\mathrm{C}$ or below in a dark place. Before usage of the RM,the compound should be allowed to warm to temperature($20\pm3^{\circ}\mathrm{C}$). The recommended minimum subsample amount for all kinds of application is 100 μ L. The expiry date of this RM is based on the current knowledge and holds only for proper storage conditions in the originally closed flasks/packages.

2.3 Hazardous situation

3.1 Calculation of uncertainty

After the concentration of the gravimetric prepared solution was confirmed by HPLC-DAD, the uncertainty of the calibrant was calculated on the basis of preparation^[3].



4.Discussion of traceability

This calibrant is certified on the basis of gravimetric preparation^[4]. Thus the certified value(mass concentration of Aflatoxin G_2 is based on the weighed amount of the starting material and is therefore traceable to the stated purity of the solid raw material. High purity material represents a practical realization of concentration units, through conversion of mass to molar quantity.

5. Confirmation of certified value by HPLC-DAD

The certified concentration of Aflatoxin G_2 of the gravimetric prepared solution was confirmed by HPLC-DAD against an independently prepared reference batch of Aflatoxin G_2 .
