2.1 Intended use of the RM

2.2 Reconstitution instruction

The standard that you have received may appear at first glance, as an empty vial. The target compound (s) is (are) in a film at the bottom of the vial. Do not open the vial until you are ready to reconstitute

To reconstitute this RM use the following procedure:

- 1. Add 1.2mL of acetonitrile with a graduated syringe or a volumetric pipette.
- 2. Cap vial tightly.
- 3. Mix vigorously on a vortex mixer and repeat for several times over a longer period or sonicate at room temperature.
- 4. Always keep vial tightly capped.
- 5. Store the reconstituted standard at -20°C in a dark environment for max. 8 weeks.
- 6. Store immediately at -20°C after usage to avoid degradation.

Note: Thorough mixing and sufficient mixing time is required to ensure complete reconstitution of the dried down standard!

2.3 Instruction for the correct use of the RM

The compound should be stored at -20°C in a dark place.Before usage of the RM,the compound should be allowed to warm to temperature(20±3°C).The recommended minimum sub-sample amount for all kinds of application is 100 μL.The expiry date of this RM is based on the current knowledge and holds only for proper storage conditions in the originally closed flasks/packages.

2.4 Hazardous situation

The normal laboratory safety precautions should be observed when working with this RM.Further details for the handing of this RM are available as safety data sheet.

3.1 Calculation of uncertainty

- a Maximum tolerance of purity (rectangular distribution) was divided by $\sqrt{3}$



4. Discussion of traceability

Thus the certified value(mass concentration of Enniatins are based on the weighed amount of the starting material and is therefore traceable to the stated purity of the solid raw material. High purity material represents a practical realization of concentration units, through conversion of mass to molar quality.

5. Confirmation of certified value by HPLC-DAD

The certified concentration of Enniatins of the gravimetric prepared solution was confirmed by HPLC-DAD against an independently prepared reference batch of Enniatins.
