

## 5.Discussion of traceability

This calibrant is certified on the basis of gravimetric preparation [4]. Thus the certified value(mass concentration of U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>1</sub>,98.09 atom%  $^{13}C$ ,U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>2</sub>,98.36 atom%  $^{13}C$ ,U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>3</sub>,98.05 atom%  $^{13}C$  is based on the weighed amount of the starting material and is therefore traceable to the stated purity of the solid raw material.High purity material represents a practical realization of concentration units,through conversion of mass to molar quantity.

#### 6. Confirmation of certified value by HPLC-FLD

The certified concentration of U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>1</sub>,98.09 atom%  $^{13}C$ ,U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>2</sub>,98.36 atom%  $^{13}C$ ,U-[ $^{13}C_{34}$ ]-Fumonisin B<sub>3</sub>,98.05 atom%  $^{13}C$  of the gravimetric prepared solution was confirmed by HPLC-FLD against an independently prepared reference batch of unlabeled Fumonisin B<sub>1</sub>,B<sub>2</sub>,B<sub>3</sub> calibrant .
