4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media:** Dry chemical, foam, water spray, carbon dioxide.
- Specific hazards arising from the chemical:** Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
