4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:	Dry chemical, foam, water spray, carbon dioxide.
Specific hazards arising from the chemical:	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
Precautions for firefighters:	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used.
