### 5. FIRE-FIGHTING MEASURES

<b>Suitable extinguishing media:</b>	Dry chemical, foam, water in large amounts, carbon dioxide.
<b>Specific hazards arising from the chemical:</b>	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
<b>Precautions for firefighters:</b>	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

### 6. ACCIDENTAL RELEASE MEASURES

### Precautions for safe handling

Use a ventilation, local exhaust if vapour or aerosol will be generated.
