4. FIRST AID MEASURES

Specific hazards arising from the chemical:	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.

Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
Environmental precautions:	Prevent product from entering drains.
Methods and materials for containment and cleaning up:	Absorb spilled material in a suitable absorbent (e.g. rag, dry sand, earth, saw-dust). 7. HANDLING AND STORAGE

Precautions for safe handling

Technical measures:	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Keep away from flames and hot surfaces. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated.
Advice on safe handling:	Avoid contact with skin, eyes and clothing. A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.

Storage conditions:	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store under inert gas. Store away from incompatible materials such as oxidizing agents. Air-sensitive
