Suitable: Carbon dioxide, dry chemical powder, or appropriate foam.

Unsuitable: Carbon Dioxide, dry chemical powder, or appropriate foam. Water can be applied as a spray or fog and if properly applied is capable of extinguishing the fire by sweeping the

flames off the surface of the burning liquid.

#### SPECIAL RISKS

Specific Hazard(s): Vapor may travel considerable distance to source of ignition and flash back. Emits toxic fumes under fire conditions.

Explosion Hazards: Vapor may travel considerable distance to source of ignition and flash back. Container explosion may occur under fire conditions. Forms explosive mixtures in air.
