SIGNS AND SYMPTOMS OF EXPOSURE

General signs of toxicity for overexposure to tetraalkyl tin compounds include muscular weakness and paralysis, leading to respiratory failure, tremors, convulsive movements, closure of the eyelids, and photophobia. Histologically, tetraalkyl tin compounds show a decrease in cytoplasmic basophilia of the liver, chromatolysis of the Purkinje cells of the cerebellum, and increase in the water content of the brain and spinal cord. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

ROUTE OF EXPOSURE

Skin Contact: May cause skin irritation.

Eye Contact: May cause eye irritation.

Multiple Routes: May be harmful by inhalation, ingestion, or skin absorption.
