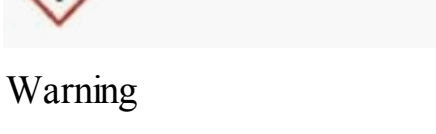

4. FIRST AID MEASURES

General advice

Precautions for safe handling

Conditions for safe storage

Handle under argon. Store under argon. Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.

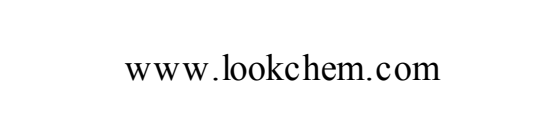
