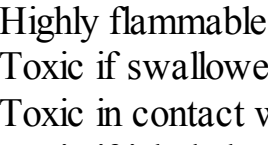

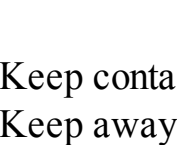

General advice
