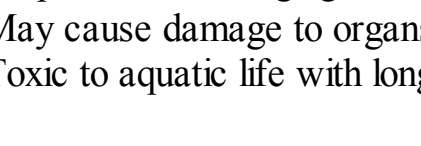

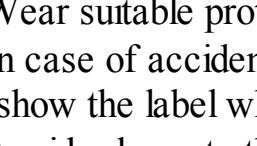

General advice
