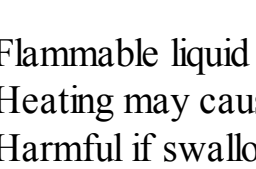

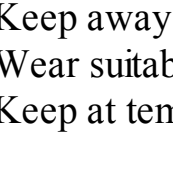

Suitable extinguishing media
