Hand protection

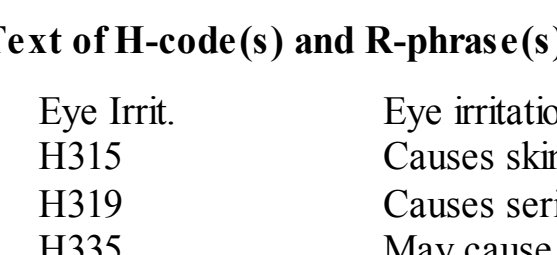
