Hand protection

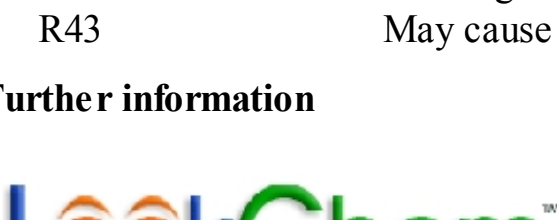
