4. FIRST AID MEASURES

General advice

Signs and Symptoms of Exposure

prolonged or repeated exposure can cause:, Yohimbine produces competitive alphaadrenergic blockade and blocks 5- hydroxytryptamine receptors. It penetrates the CNS readily producing a complex pattern of responses which include antidiuresis, elevations of blood pressure and heart rate, increased motor activity, irritability and tremor, sweating, nausea, and vomiting. It is a selective inhibitor of alpha-2 adrenergic receptors enhancing neural release of norepinephrine., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
