General advice

Hand protection

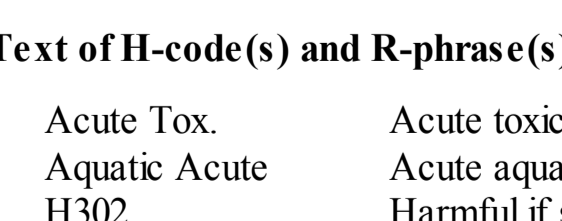
