General advice

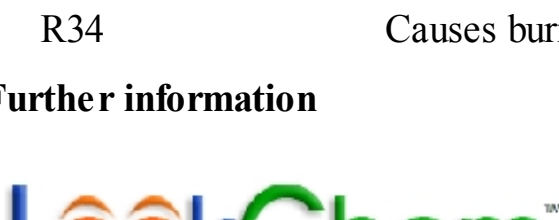
