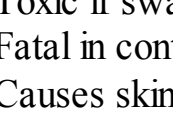

General advice

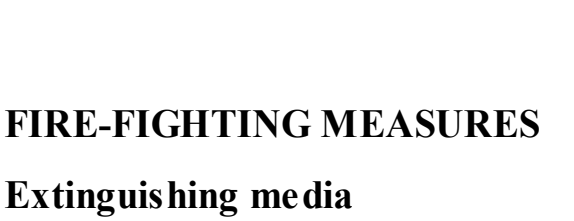
