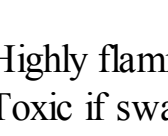

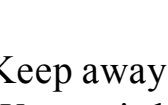

Skin protection

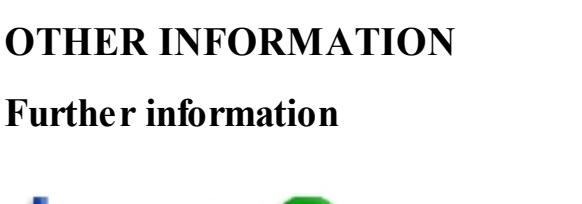
