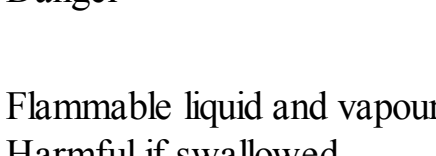

4. FIRST AID MEASURES

General advice

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media

6. ACCIDENTAL RELEASE MEASURES

Personal precautions
