4 - First Aid Measures

AFTER INHALATION

HANDLING

Directions for Safe Handling: Avoid breathing vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged or repeated exposure.

STORAGE

Conditions of Storage: Keep tightly closed. Keep away from heat, sparks, and open flame. Handle and store under nitrogen. Unsuitable: In the absence of inhibitors, tetrahydrofuran tends to absorb and react with oxygen from the air to form explosive peroxides which may detonate when they become concentrated by evaporation or distillation, are combined with other compounds resulting in an explosive mixture or are disturbed by heat, shock, or friction. Store at 2-8°C

SPECIAL REQUIREMENTS: Store under inert gas. Do not distill to dryness. Test for peroxide formation periodically and before distillation.

ENGINEERING CONTROLS

Safety shower and eye bath. Use nonsparking tools. Mechanical exhaust required.

GENERAL HYGIENE MEASURES

Wash thoroughly after handling. Wash contaminated clothing before reuse.
