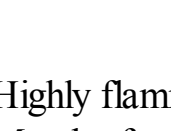

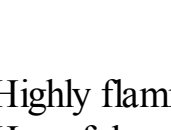

Suitable extinguishing media

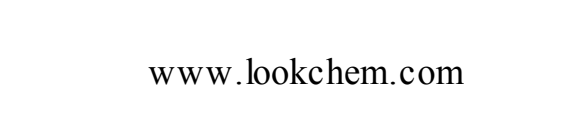
