General advice

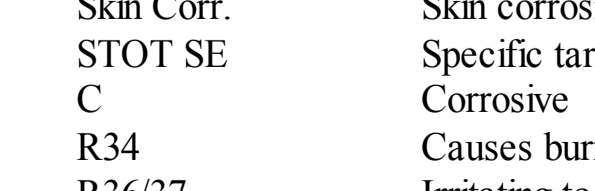
