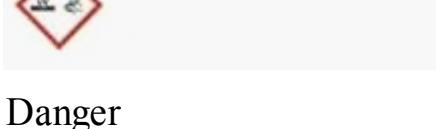

4. FIRST AID MEASURES

Respiratory protection
