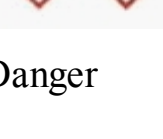

General advice

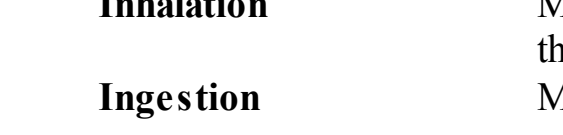
