Hand protection

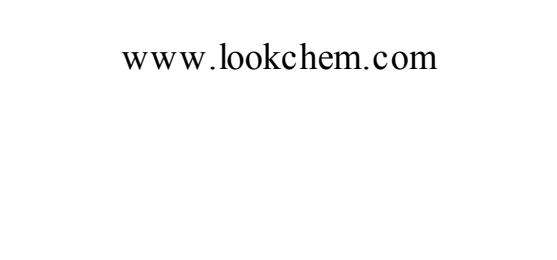
