4. FIRST AID MEASURES

4.1 Description of first aid measures

General advice

5. FIRE-FIGHTING MEASURES

5.1 Extinguishing media

Suitable extinguishing media

For small (incipient) fires, use media such as "alcohol" foam, dry chemical, or carbon dioxide. For large fires, apply water from as far as possible. 6.1 Personal precautions, protective equipment and emergency procedures

7.1 Precautions for safe handling
