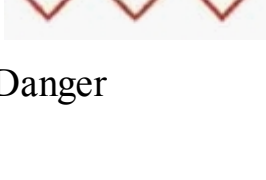

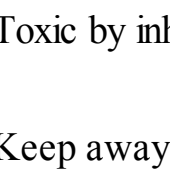

Appropriate engineering controls

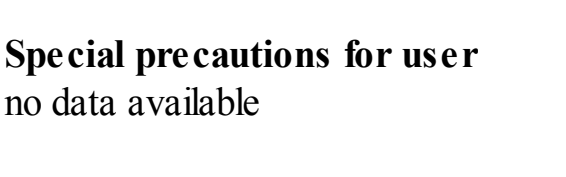
