Suitable extinguishing media

Body Protection

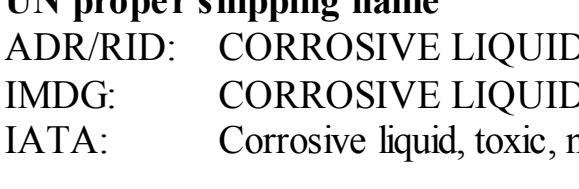
