AFTER INHALATION

STABILITY

Conditions to Avoid: A mixture of benzyl alcohol and 58% sulfuric acid decomposed violently when heated to 180°C. Benzyl alcohol containing 1.4% hydrogen bromide and 1.1% of an iron(II) salt polymerized exothermally when heated above 100°C.
