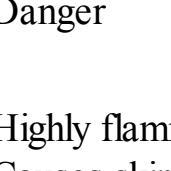

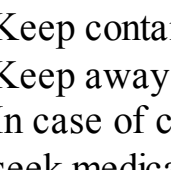

Suitable extinguishing media

Skin protection
