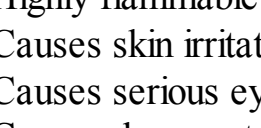

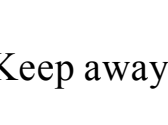

4.1 Description of first aid measures

General advice

5.1 Extinguishing media

Suitable extinguishing media

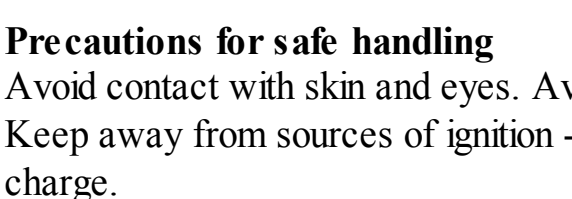
