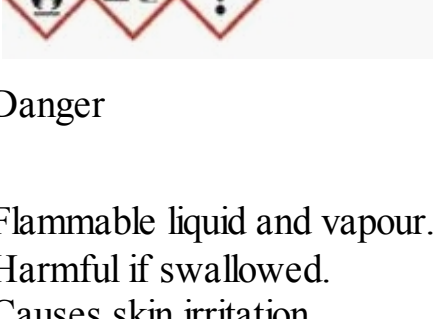

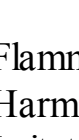

General advice

5.1 Extinguishing media

Suitable extinguishing media

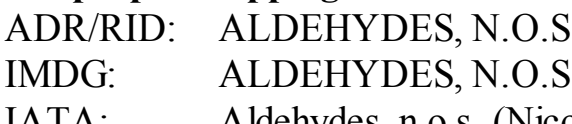
