

General advice

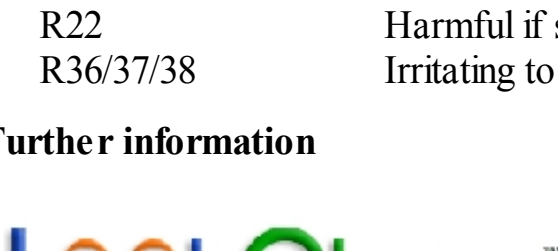
