General advice

### 4.2 Most important symptoms and effects, both acute and delayed

Because of the similarity in structure of the penicillins and cephalosporins, those who are allergic to one class of agents may manifest cross-allergenicity when a member of the other class is encountered. Nausea, Vomiting, May occur in combination with exposure to alcohol. Significant and sometimes fatal bleeding, interference with hemostasis via hypoprothrombinemia with or without bleeding, platelet dysfunction, immune-mediated thrombocytopenia. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

Appropriate engineering controls
