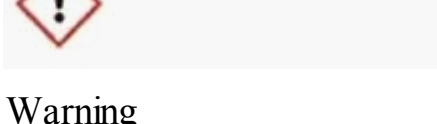

Hand protection

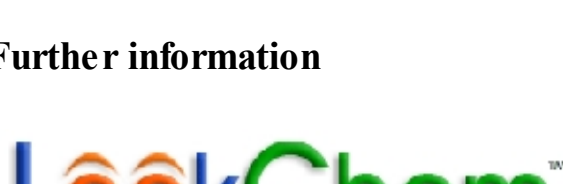
